## **TRANSFERRING STOCK TO IT IS WRITTEN**

Making a stock gift is an easy and tax-wise way to build a legacy in the Kingdom of God by providing a gift to It Is Written. A gift of appreciated securities saves taxes twice. You may receive an income tax deduction for the full market value of the donated shares if you have held the securities for more than one year, and you may avoid capital gains tax on the appreciation.
